3	Brief profile (in case of appointment).	Mr. Lim Tsin-Lin, aged 44 years, was appointed to the Board of IHH Healthcare Berhad in February 2023. Mr. Lim Tsin-Lin is currently the Head of Healthcare and Head of Dana Impak of Khazanah Nasional Berhad (Khazanah). He was a key member of the team that set up Khazanah's first foreign office in Beijing in 2008 and was subsequently appointed Head of China in 2017. After serving 13 years overseas, he returned to Malaysia in 2021 to assume his current role in Khazanah. Prior to Khazanah, he was with Ernst & Young, Rating Agency Malaysia Bhd and ECM Libra Securities Sdn Bhd.
		Mr. Lim Tsin-Lin is a Chartered Financial Analyst (CFA) and holds Master in Business Administration from the MIT Sloan Fellows Programme, the Massachusetts Institute of Technology, United States and Bachelor of Commerce and Management from Lincoln University, New Zealand.
