## Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

This is in furtherance to our letter dated June 30, 2023 regarding the approval of the shareholders of the Company by way of postal ballot circulated for seeking approval for entering into a intra group restructuring involving entities that are directly/indirectly 100% owned by the Company, by way of a Composite Scheme of Arrangement between International Hospital Limited, Fortis Hospitals Limited and Fortis Hospotel Limited (collectively referred as wholly-owned subsidiaries) and their respective shareholders and creditors.

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**Listing Regulations**"), this is to inform you that Board of Directors of Fortis Hospitals Limited (a material subsidiary of the Company) in its meeting held today i.e. July 27, 2023, has, subject to approval of National Company Law Tribunal ("**NCLT**") or any other relevant authority, approved this intra group restructuring involving entities that are directly/indirectly 100% owned by the Company, by way of a 'Composite Scheme of Arrangement' that provides for -

- (i) Demerger of the hospital operations of the Kalyan undertaking, Amritsar undertaking, Faridabad undertaking, Kolkata (Anandpur) undertaking, FHKI undertaking, Noida undertaking and Mulund undertaking of Fortis Hospitals Limited and the transfer and vesting of the same to International Hospital Limited; and
- (ii) Demerger of the hospital operations of FMRI Gurgaon Undertaking of Fortis Hospitals Limited and the transfer and vesting of the same to Fortis Hospotel Limited

on such terms and conditions, as contained in the said Composite Scheme of Arrangement, which *inter alia* includes the issuance of shares and compulsorily convertible preference shares by International Hospital Limited and Fortis Hospotel Limited to the shareholders of Fortis Hospitals Limited, as consideration for the Composite Scheme of Arrangement.
